## Section 2: HAZARDS IDENTIFICATION

## Section 3: COMPOSITION/INFORMATION ON INGREDIENTS

**General information:** Aqueous solution of recombinant human Intrinsic Factor (IF).

**Ingredients:** This product is a mixture of substances.
