Section 2: HAZARDS IDENTIFICATION

Classification: This substance does not need to be classified according to regulation (EC) No. 1272/2008.
Label: This product does not need to be labeled in accordance with EC directives or respective national laws.
Other hazards: This product contains protein of bovine origin. Each animal has been tested according to EU food safety standards. However, no known test can offer complete assurance that disease transmitting agents are not present. Handle as if capable of transmitting infectious agents.

Section 3: COMPOSITION/INFORMATION ON INGREDIENTS

General information: Aqueous solution of non recombinant bovine Sm.
REACH registration number: No registration number is given yet for this mixture since the annual import quantity is less than one tonnage per annum or the transition period for its registration according to Article 23 of REACH has not yet expired.
Ingredients: This product is a mixture of substances. According to regulation (EC) No. 1272/2008, mixtures with hazardous and carcinogenic ingredients with a concentration of less than 1% and 0.1%, respectively, are not considered "relevant ingredients". Section 4: FIRST AID MEASURES
