1. Organization Structure and Supply Chain

Our Supply Chain

Our supply chain includes direct and indirect suppliers, predominantly, in Europe, North America and Australasia

Risk assessment and Management:

Our approach to risk assessing our supply chain is based on a number of factors, including:

- Size of company (supplier)
- Location
- Labour practices
- Code of conduct and compliance

We have a supplier management organisation to oversee procurement globally. Procedures are in place for the onboarding and control of all suppliers.

2. Our Policy on Modern Slavery and Human Trafficking

We are committed to ensuring that there is no slavery or human trafficking in our supply chain or any part of our business.

BBI Solutions strictly prohibits the use of slave labour and any engagement in human trafficking. We require all suppliers to acknowledge and comply with our stance. BBI requires that our entire supply chain conduct business in a manner that respects human rights.

3. Due Diligence Process

As part of our process to identify and mitigate risk, we ensure that we:

- Identify, assess and monitor potential risk areas in our supply chains
- Mitigate the risk of slavery and human trafficking occurring in our supply chain
- Monitor potential risk areas in our supply chain
- Protect whistle blowers

We continuously review our workplace policies and procedures to ensure their effectiveness. These policies and procedures demonstrate our commitment to acting ethically and with integrity in all our business relationships and to implementing and enforcing effective systems and controls to ensure, as far as practicable, that slavery and human trafficking is not taking place anywhere in our supply chain.

If any supplier is unwilling or unable to comply with supplier standards, including those regarding slavery and human trafficking, we take appropriate action. This may include the cancellation of purchase orders or contracts as well as alerting local authorities of any confirmed or suspected illegal activity.

4. Risk Assessment and Management

As part of our Supply Chain risk management process we continuously assess, mitigate and monitor our supply base regarding the potential presence of slavery and human trafficking at our vendors and partners.

5. Key Performance indicators

100% of new suppliers vetted for Ethical compliance. Strategic Suppliers to be signed up to our Supplier code of conduct by the end of 2022

6. Training

All BBI employees with direct responsibility for supply chain management are trained in ethical procurement.

To ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and throughout our business, provide training to our staff. We will also require our business partners to provide training to their staff, suppliers and providers.
