## Section 2: HAZARDS IDENTIFICATION

**Classification:** This mixture does not need to be classified according to regulation (EC) No. 1272/2008.

## Section 3: COMPOSITION/INFORMATION ON INGREDIENTS

**General information:** Aqueous solution of recombinant *Anaplasma phagocytophilum* Major surface protein 5 (Msp5).  
**REACH registration number:** No registration number is given yet for this mixture since the annual import quantity is less than one tonnage per annum or the transition period for its registration according to Article 23 of REACH has not yet expired.  
**Ingredients:** This product is a mixture of substances.
